1. Submission and Peer Review Process

Once the submission materials have been prepared in accordance with the Author Guidelines, manuscripts should be submitted online at wiley.atyponrex.com/journal/CDQ.

This journal does not charge submission fees.

Article and Free Format Submission

In addition to the usual structured submission, *The Career Development Quarterly* also offers <u>Free Format submission</u> for a simplified and streamlined submission process.

General Submission Information:

- Manuscripts must be prepared using APA Style (7th ed.): Publication Manual of the American Psychological Association (7th ed.; APA, 2020).
 - If you are unfamiliar with APA Style, please see: <u>https://apastyle.apa.org/</u>
 - Formatting must adhere to APA Journal Article Reporting Standards (JARS)
- Typical manuscript length is 25-30 pages, inclusive of main body, references, tables, and figures.
- All submissions are automatically reviewed by Crossref, an online plagiarism similarity check

Before you submit, you will need:

- The title page of the manuscript, including:
 - A brief informative title containing the major keywords. The title should not contain abbreviations (see <u>Wiley's best practice SEO tips</u>).
 - Coauthor details: full name, institutional affiliation where the work was conducted, with a footnote for each author's present address if different, and email address. (*Why is this important? We need to keep all coauthors informed of the outcome of the peer review process.*)
- An ORCID ID: This is freely available at https://orcid.org. (Why is this important? Your article, if accepted and published, will be attached to your ORCID profile. Institutions and funders are increasingly requiring authors to have ORCID IDs.) This journal encourages ORCID. Please refer to <u>Wiley's resources on ORCID</u>.
- Abstract: The abstract should not exceed 150 words and should express the central idea of the manuscript.
- Keywords: Three to five keywords that convey the main topics and best promote search optimization of your work.
- Acknowledgments
- Statements relating to our ethics and integrity policies, which may include any of the following (*Why are these important? We need to uphold rigorous ethical standards for the research we consider for publication.*):
 - data availability statement
 - funding statement
 - conflict of interest disclosure
 - ethics approval statement
 - client/participant consent statement
 - permission to reproduce material from other sources
 - clinical trial registration
- Your manuscript: This should be a single editable file that includes the main text, references, figures, and tables. Typical manuscript length, inclusive of text, references, figures, and tables, is 25-30 pages.
 - Main text: All required sections should be contained in your main text file, including abstract, keywords, introduction, method, results, discussion, limitations and future directions, and conclusion.

- References: References should be prepared according to the *Publication Manual of the American Psychological Association* (7th ed.). In-text citations should follow the author-date method (e.g., Jones, 2020). A complete reference list should be presented alphabetically by last name at the end of the article. Verify that all citations in the text are listed in the reference section, and vice versa, and that the spelling of author names and years are consistent. A DOI should be provided for all references where available. References should be double-spaced like the main text.
- Manuscript Types: CDQ offers two options for manuscript types.
 - Research Article: Manuscripts regarding career development, education, and counseling for diverse individuals across the lifespan. Qualitative, quantitative, mixed methods, and rigorous reviews of the literature accepted.
 - Practice Development: The new Practice Development article type will focus on exploring effective career interventions. This section is designed for manuscripts that explore and assess the impact of career development or career counseling interventions. Empirical data must be collected and analyzed, and may include any of the following: randomized control trial, quasi-experimental designs, pre-post tests, program evaluation results, single-case findings, pilot study, or other empirical data collected to better understand the impact and possible effectiveness of a career development or counseling intervention. When submitting, please choose the article type Practice Development.
- Figures and Tables: We allow a maximum of six figures and tables total unless a strong rationale is provided for why additional figures and tables are needed.
 - Figures: Each figure must be complete with title, and all abbreviations must be defined in the figure note. Figures should be uploaded in the highest resolution possible (e.g., at least 150–300 dpi). Include definitions of all symbols used in the figure and explain all units of measurement. Figures can be uploaded as separate files. Please only include figures when necessary for the reader to comprehend the results of your study.
 - Tables: Each table must be complete with title, and all abbreviations must be defined in the table note. Footnotes should consist of letters (in alphabetical order as a, b, c, etc.), and *p* values should be presented as asterisks in the table and explained in the table note. Please include effect size when available. We encourage the use of tables for empirical data; data included in a table does not need to be repeated in text, but you should refer to the table in the text.
 - Supplementary information should be submitted in separate files.
 - If the text, figures, or tables are difficult for you to read, they will also be difficult for the Editors and reviewers, and the Editorial Office will send it

back to you for revision. Your manuscript may also be sent back to you for revision if the quality of English language is poor.

Artificial Intelligence (AI)

• The use of artificial intelligence (AI) to support the work submitted by authors is to be cautiously undertaken, as the nature of AI is dynamic and not necessarily transparent. Any AI tools employed in the creation of a submission (e.g., large language models (LLMs), chatbots and image creators) must preserve the requirements of the publication, including but not limited to, originality, accuracy and professional integrity. Tools are the responsibility of the author to vet. Avoiding the generative use of AI, while cautiously considering editing use, is recommended.

Important: Articles are peer reviewed under a double-blind policy. Please anonymize your manuscript and supply a separate title page file. Upon acceptance, you will be asked to submit a fully nonblinded, final version of your article.

Do not use footnotes or endnotes in the article; incorporate any such material into the text.

Figures and Supporting Information

Figures, supporting information, and appendices can be supplied as separate files. You should review the <u>basic figure requirements</u> for manuscripts for peer review, as well as the more detailed post-acceptance figure requirements. View <u>Wiley's FAQs</u> on supporting information.

Color figures. Color figures may be published online free of charge; however, the journal charges for publishing figures in color in print. If the author supplies color figures at Early View publication, they will be invited to complete a color charge agreement in RightsLink for Wiley Author Services. The author will have the option of paying immediately with a credit or debit card, or they can request an invoice. If the author chooses not to purchase color printing, the figures will be converted to black and white for the print issue of the journal.

This journal is a hybrid journal that publishes both subscription and open access articles. You will have the option to choose to make your article open access after acceptance, which will be subject to an article publication charge (APC). You can <u>read</u> <u>more about APCs</u> and whether you may be eligible for waivers or discounts through your institution, funder, or a country waiver.

The Career Development Quarterly will consider for review articles previously available as preprints. You may also post the submitted version of a manuscript to a preprint server at any time. You are requested to update any prepublication versions with a link to the final published article.

However, because articles are peer reviewed under a double-blind policy, please note that if authors share their manuscript in preprint form, this may compromise their anonymity during peer review.

All listed authors should have contributed to the manuscript substantially and have agreed to the final submitted version. Review Wiley's <u>editorial standards</u> for a description of authorship criteria.

Reproduction of Copyright Material

If lengthy excerpts (generally 400 cumulative words or more from one source) are included, or if previously published tables or figures from copyrighted works owned by third parties are reprinted in their entirety, in part, or adapted, credit must be given. The corresponding author is responsible for obtaining written permission to reproduce the material in print and other media from the publisher of the original source, and for supplying Wiley with that permission upon submission.

Peer Review

Articles are peer reviewed under a double-blind policy. Manuscripts will only be sent for review if the Editor determines that the manuscript meets the appropriate quality and relevance requirements.

In-house submissions (i.e., papers authored by Editors or Editorial Board members of the journal) will be sent to Editors unaffiliated with the author or institution and monitored carefully to ensure there is no peer review bias.

2. After Acceptance

First Look

After your manuscript is accepted, your files will be assessed by the Editorial Office to ensure they are ready for production. You may be contacted if any updates or final files are required. Otherwise, your manuscript will be sent to the Wiley production team.

Wiley Author Services

When an accepted article is received by Wiley's production team, the corresponding author will receive an email asking them to log in or register with <u>Wiley Author</u> <u>Services</u>. You will be asked to sign a publication license at this point as well as pay for any applicable APCs.

Copyright & Licensing

You may choose to publish under the terms of the journal's standard copyright agreement or Open Access under the terms of a Creative Commons (CC) license.

Standard <u>reuse and licensing rights</u> vary by journal. Note that <u>certain funders</u> mandate a particular type of CC license be used.

Self-Archiving Definitions and Policies: Note that the journal's standard copyright agreement allows for <u>self-archiving</u> of different versions of the article under specific conditions.

Proofs

Authors will receive an email notification with a link and instructions for accessing HTML page proofs online with their proofs included as a PDF. Authors should make sure that any renumbered tables, figures, or references match text citations. Proofs must be returned within 48 hours of receipt of the email.

Appendix

Embedded Rich Media

This journal has the option for authors to embed rich media (e.g., video, audio) within their final article. These files should be submitted with the manuscript files online, using either the "Embedded Video" or "Embedded Audio" file designation. If the video/audio includes dialogue, a transcript should be included as a separate file. **The combined manuscript files, including video, audio, tables, figures, and text, must not exceed 350 MB.** For full guidance on accepted file types and resolution, please see <u>here</u>. Ensure each file is numbered (e.g., Video 1, Video 2). Titles for the rich media files should be placed at the end of the article.

The content of the video should not display overt product advertising. Educational presentations are encouraged.

Any narration should be in English, if possible. A typed transcript of any speech within the video/audio should be provided. An English translation of any non-English speech should be provided in the transcript.

All embedded rich media will be subject to peer review. Editors reserve the right to request edits to rich media files as a condition of acceptance. Contributors are asked to be succinct, and the Editors reserve the right to require shorter video/audio duration. The video/audio should be high quality (both in content and visibility/audibility). The video/audio should make a specific point; particularly, it should demonstrate the features described in the text of the manuscript.

Participant Consent: It is the responsibility of the corresponding author to seek informed consent from any identifiable participant in the rich media files. Masking a participant's eyes or excluding the head and shoulders is not sufficient. Please ensure that a consent form (<u>https://authorservices.wiley.com/author-resources/Journal-Authors/licensing/licensing-info-faqs.html</u>) is provided for each participant.
